I further say that the right of way granted the Skamania Light and Power Company lies outside of the area to be flooded by the Bonneville Project and is not affected by the flowage easement which I granted to the United States of America; that there are no existing r roads or highways, other than excepted in the flowage easement granted to the United States of America, lying within the area to be flooded by the Bonneville Project.

I also say that I am sometimes known as H. B. Smith and that I was one of the grantees in that certain deed recorded in Book "T" of Deeds, page 92, Records of Skamania County, Washington, and also in that certain deed recorded in Book "T" of Deeds, page 94, Records of Skamania County, Washington; that I make this affidavit for the purpose of meeting certain objections as set forth in the opinion of the Attorney General under date of October 13, 1936.
