

## SKAMANIA COUNTY, WASHINGTON

I further say that the Northwestern Electric Company's transmission line is on high land and not within the area of the land to be flooded by the Bonneville Project nor is the transmission line of said company within that portion of the lands over which the United States of America acquired a flowage easement.

I also say that that certain mortgage made by Thos. H. Menice in favor of C. W. Bergman and Gus Klang, dated April 20, 1908 and recorded April 20, 1908 in Book "H" of Mortgages, page 167, Records of Skamania County, Washington, given to secure the payment of \$183.53, is no longer a lien against that land in Lot 4, Section 35, and that the same has been paid.

I further say that since January 13, 1903 I have known S. S. Hayes, who was one of the grantees in that certain deed dated January 13, 1903 and recorded January 16, 1903 in Book "H" of Deeds, page 357, Records of Skamania County, Washington, and wherein W. A. Murchie and May Murchie, husband and wife, W. H. Biggs and M. E. Biggs, husband and wife, and David Fulton and Lulu B. Fulton, husband and wife, were grantors, and said S. S. Hayes was also one of the grantees in that certain deed dated December 29, 1905 and recorded January 16, 1906 in Book "I" of Deeds, page 396, Records of Skamania County, Washington, and wherein the State of Washington was grantor; that at the time S. S. Hayes acquired this property he acquired all right, title and interest thereto, as separate property, and conveyed the same out to me as his separate property by quitclaim deed dated June 2, 1919 and recorded June 21, 1919 in Book "R" of Deeds, page 149, Records of Skamania County, Washington, wherein S. S. Hayes was designated as a widower.

I further say that I make this affidavit for the purpose of removing certain objections as pointed out in the Attorney General's opinion of December 1, 1936.
