Nancy G. Wallace to The Public

Nancy G. Wallace, being first duly sworn, says: I am the grantee named in that certain deed made and executed by Walter B. Warren and Catharine R. Warren, husband and wife, to Nancy G. Wallace dated February 10, 1925, and recorded March 25, 1925, at page 223 Book "U" of Deeds, records of Skamania County, Washington, wherein certain lots situated in the townsite of Cooks, Washington, together with "all of the shore lands of the second class in front of and adjacent to Lot 3 in Section 34 in Township 3 North of Range 9 East of W.M., subject to the right of way of the Spokane, Portland and Seattle Railway Company" were conveyed to me; that my predecessor in interest, Walter B. Warren, acquired the said property by sheriff's deed dated April 13, 1921, recorded at page 255 Book "S" of Deeds, records of Skamania County, Washington.

About 1921 an arrangement was made between the said Walter B. Warren and myself whereby I agreed to occupy and manage all of the property acquired by him including all of the
