Warren or myself and during said time paid taxes upon the said property. Such possession was open, notorious and adverse to the entire world and such possession was claimed and held under color of title.

My attention is called to the fact that the description in the deed to the said Walter B. Warren and from the said Walter B. Warren to myself does not cover the up-land situated in Lot 3, Section 34, Township 3 North of Range 9 East of W.M., lying South of the S. P. & S. Railway. This omission was the result of a mutual mistake and title to all of said property has actually been claimed and vested in the said Walter B. Warren and myself for a period of more than 15 years.

The Cooks Investment Company and the Cooks Mercantile Company were corporations doing business in Cooks, Washington prior to about 1915 and they have both long since been out of existence and dissolved by operation of law. Neither of said companies nor the directors or stockholders thereof have ever claimed or asserted title since the date of Sheriff's sale upon which deed to the said Walter B. Warren was made.
