I also say that the Skamania Boom Company, a corporation, has not operated within the vicinity of the land over which a flowage easement was granted to the United States of America, as above mentioned, for a number of years; and that they never operated upon the lands over which said flowage easement was granted, and that there is not now and never was any merchantable timber on the lands covered by the said flowage easement. I also say that I know the location of the gold mining property of the Columbia Gold and Copper Mining Company, as reserved to said company by that certain deed dated May 17, 1909 and recorded May 18, 1909 in Book "L" of Deeds, page 428, Records of Skamania County, Washington, and that said mining property is on high lands and in no way involved in the land covered by the flowage easement above referred to.

That I make this affidavit for the purpose of meeting certain requirements as set forth in the Attorney General's opinion dated January 9, 1937 relative to the clearing of title to the land over which I granted a flowage easement to the United States of America, above mentioned.
