WRIGHT, being first duly sworn, says: I am now and for many years past have been an attorney at law and notary public residing at Stevenson, Skamania County, Washington; that prior to March 4, 1921, I was employed by Fred F. Menzel and Robert W. French to draw a deed covering a tract of land in Lot 9, Section 1, Township 2 N. R. 7 E. W.M., Skamania County, Washington, which was described in said deed substantially as follows:

Commencing at a point on the south boundary line of Second Street in the town of Stevenson at a point which is 602.2 feet south and 360 feet west of the point of intersection of the west line of the Shepard Donation Land Claim with the Township line of Townships 2 and 3 North, Range 7 East of the Willamette Meridian; thence from said initial point south 259 feet; thence south 89 deg. 45' west 200 feet; thence north 259 feet, more or less, to the south line of said Second Street; thence east to the place of beginning, all being in Skamania County, Washington.
