I, F. McKelvey, being first duly sworn, depose and say: That I am the same person, who, with my wife, Myrtle McKelvey, on the 9th day of November, 1936, executed a flowage easement wherein we granted to the United States of America a flowage easement over a portion of our lands in the NW $\frac{1}{4}$  NW $\frac{1}{4}$  and Government Lot 8, Section 1, Township 2 North, Range 7 East of the Willamette Meridian, Skamania County, Washington, wherein the consideration was \$2750.00. I further say that there are no vested or accrued water rights, nor ditch or reservoir rights used in connection with the lands over which we granted a flowage easement to the United States of America existing by reason of local customs, laws or decisions, nor are there any parties in possession of said lands other than the grantors in said flowage easement. I also say that there are no mechanics' lien claims not shown of record that affect said lands.

I further say that that land conveyed by deed dated August 6, 1928 and recorded December 29, 1928 in Vol. "W" of Deeds, page 76, Records of Skamania County, Washington, R. L. Nicholson to F. McKelvey, is not included in the land described in that certain flowage easement above mentioned.

That I make this affidavit for the purpose of meeting certain requirements as pointed out in the Attorney General's opinion of December 28, 1936.
