Marshall and Bernice Marshall, husband and wife, parties of the first part for and in consideration of the sum of Ten Dollars lawful money of the United States of America to them in hand paid, by Forrest Marshall, the receipt whereof which is hereby acknowledged, have Granted, Bargained and Sold and by these presents do Grant, Bargain, Sell and Convey unto the said Forrest Marshall, party of the second part, and to his heirs and assigns, the following described real property situate in Skamania County, State of Washington, to-wit:
