Iman Donation Land Claim in Section Two (2) Township Two (2) North of Range Seven (7) East of Willamette Meridian which lies South of the railroad tract of the Portland & Seattle Railway Company, dated September 30, 1907 and recorded at page 136 Book "L" of Deeds, records of Skamania County, Washington. That by the terms of said deed there was reserved a right of way to be selected by the grantors for a wagon road; that the said road was so selected by the grantors and constructed over and across the property therein described.
