NOW, THEREFORE, the said Grantor, for and in consideration of the sum of ONE THOUSAND FIFTY AND 00/100 (\$1,050.00) DOLLARS, cash in hand paid by the Government, the receipt where of is hereby acknowledged, does hereby grant, bargain, sell and convey to the Government, or its assigns, forever, the full and perpetual right, power, privilege and easement to overflow, as hereinbefore stated, all the following described lands situate in the County of Skamania and State of Washington:

Lots 1 to 8 inclusive and Lots 21 to 28 inclusive in Block 3 of Stevenson, according to the official plat on file and of record in the office of the Auditor of Skamania County, Washington;

Also all that portion of the 16-foot alley in said Block 3 extending from the east line of Block 3 to the west line of said Lots 8 and 21; also the northerly 30 feet of Front Street adjacent to Lots 1 to 8 inclusive, the northwest quarter of the intersection of Front and Seymour Streets, and the westerly 30 feet of Seymour Street adjacent to said Lots 1 and 28, being vacated alley, streets and avenuesas shown by that certain ordinance recorded July 23, 1923, in Book "G" of Miscellaneous, page 34, Records of Skamania County, Washington.
