eration, does hereby convey and warrant unto Carl Kirkpatrick, a single man, and H. G. Kirk-
patrick, single man hereinafter referred to at the grantees, the following described real
property, to-wit:

Beginning at a point on the southerly line of the Evergreen Highway which is south
1257 feet and west 38.93 feet from the common corner of Sections 15, 16, 21 and 22, in
Township 2 North of Range 7 East of the Willamette Meridian, and running thence South
81°00' East 450 feet; thence South 9°00' West 160 feet to a point which is the true
point of beginning of the tract herein described; and running thence North 81°00' West
150 feet; thence South 9°00' West 176 feet to the Northerly line of the Spokane, Port-
land & Seattle Railway Right-of-way; thence Easterly, along said right of way, to a
point which is South 9°00' West from the place of beginning; and thence North 9°00'
East 163 feet to the place of beginning, said tract being designated as Lots 1, 2, 3,
