

## SKAMANIA COUNTY, WASHINGTON

The above described claim including a ledge of dark green stone running in a north-erly and southerly direction, crossing the South Fork of Lewis River, thence South, and the same is exposed in several places on the river, and on the hillside said green stone has the silicates well distributed and well difined, comprising twenty (20) acres.

(b) Beginning 100 feet North of the intersection of Slide creek and the south Fork of the Lewis River in Section 17, Township 4 North of Range 5 East of the Willamette Meridian; thence running 140 feet West to a point; thence West 990 feet to a point; thence South 1320 feet to a point; thence East 990 feet to a point; thence North 1320 feet to the place of beginning.

This ledge of stone is a granite, very even in texture. It shows outcroppings on the South Fork of the Lewis River on the above location, as well as other places on the claim, and comprises approximately thirty (30) acres.

(c) The beginning point is the center of the South Fork of the Lewis River at a point where it intersects the County line between Skamania and Clark Counties, in the State of Washington, running thence north on the said county line 100 feet to the point of beginning located in Section 19, Township 4 North, Range 5 East of the Willamette Meridian; thence 1320 feet North to a point on the said common County line; thence 990 feet East to a point; thence 1320 feet South to a point; thence 990 feet West to the place of beginning. This claim comprises thirty (30) acres.

And also building stone and mining claims on said pieces of land.

TO HAVE AND TO HOLD the same to the said John P. Gustafson and to his heirs and assigns forever.
