I, Emma Douglass, being first duly sworn, depose and say: That I am one of the grantors who on the 26th day of August, 1937, executed a flowage easement to the United States of America over certain lands in the Northwest Quarter of the Northeast quarter and Government Lot 5 of Section 31, Township 3 North, Range 8 East of the Willamette Meridian, Skamania County, Washington; that neither the United States nor any third person has any water rights for mining, agriculture, or other purposes, or ditches or reservoirs used in connection with such water rights on said lands; also that no proprietor of a vein or lode is removing ore from said lands; nor does the United States have any ditches or canals constructed thereon; also that there are no easements used by any third person in connection with water rights on said lands affected by flowage.

I further say that there are no parties in possession of said lands, not shown of record nor are there any mechanics' lien claims affecting said lands, not shown of record; that I make this affidavit for the purpose of meeting certain requirements as pointed out by the Attorney General's opinion dated September 27, 1937, in relation to the above matter.
