IN THE MATTER of Primary State Highway No. 8, Blue Creek to Skadat.

KNOW ALL MEN BY THESE PRESENTS, That Marie Montchalin, a widow, dealing with her separate property of the County of Skamania in the State of Washington, in consideration of the benefits and other valuable considerations, and the sum of Two Hundred and 00/100 Dollars, in hand paid, the receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the State of Washington, the following described parcel of land situated in Skamania County, in the State of Washington, to-wit:

A strip of land being all that portion of the following described tract of land that lies southeastwardly from a line parallel with and distant 200 feet northwestwardly (measured at right angles) from the center line of said highway extending from the east line of portion of hereinafter described Government Lot No. 13 in a southwestwardly direction (measured along said center line) to Engineering Survey Station 120 plus 00 as surveyed over and across Government Lot No. 13, Section 36, T. 3 N., R. 7 1/2 E.W.M., described as follows: that portion of said Gov. Lot No. 13, said township and Range lying northwestward from right of way of State Highway No. 8, excepting commencing at a point 657.4 feet west and 342.3 feet south of the quarter corner on the east line of said Section 36, T. 3 N., R. 7 1/2 E.W.M.; thence S. 36° 28' W., 298 feet; thence S. 40° 00' E. about 128 feet to the north line of the State Road right of way; thence in a northeasterly direction along said north line of right of way to a point S. 40° 00' E. of point of beginning; thence N. 40° 00' W. about 156 feet to point of beginning containing one acre, more or less,
