Baughman D. L. C.; thence east to the place of beginning, except therefrom the tract of land deeded to Chas. Oline as described at page 541, Book "Q" of Deed records of Skamania County, Washington, which tract lies northwestwardly of existing P.S.H. No. 8,

Subject to easements for roads, easements to Northwestern Electric Company for power line, right of way for a private road granted to Gust J. Melonas, also flowage easement to the United States of America

the specific details concerning all of which are to be found within that certain map of definite location now of record and on file in the office of the Director of Highways at Olympia, and bearing date of approval August 24th, 1937.
