IN CONSIDERATION of One Dollar and less than One Hundred Dollars, the receipt whereof is hereby acknowledged, the undersigned, E. P. Ash and Gertrude E. Ash, his wife, grant to NORTHWESTERN ELECTRIC COMPANY, a Washington corporation, a perpetual right-of-way in and over the following described real property situated in the County of Skamania, State of Washington, to-wit:

Commenning at a point five hundred forty-two and two-tenths (542.2) feet south of a rock marking the intersection with the west line of the Shepard D.L.C. and the north line of Section 1, Twp. 2 N. R. 7 E.W.M., in Skamania County Washington, said point being the intersection of State Road No. 8, with the east line of the tract of land belonging to the Udell Estate; thence west along the said State Road three hundred seven and eight tenths (307.8) feet; thence North two hundred seventy-six and two tenths (276.2) feet; thence east ninety-nine and one-tenth (99.1) feet; thence North fifty seven (57) feet to the Southwest corner of a lot on tract of land heretofore sold by George Udell and others to P. L.
