Seymour Hall, unmarried, dealing with separately owned property his wife, of the County of Skamania in the State of Washington, in consideration of the benefits and other valuable considerations, and the sum of One Hundred twenty-five and 00/100 Dollars, in hand paid, the receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the State of Washington, the following described parcel of land situated in Skamania County, in the State of Washington, to-wit:

A strip of land being all that portion of the following described tract of land that lies northward, from a line parallel with and distant 30 feet southwardly (measured at right angles) from the center line of said highway as surveyed over and across part of the Shepard D.L.C. in Sec. 1, T. 2 N. R. 7 E.W.M. described as follows: commencing at a point 30 feet south of the NW corner of First and Seymour Streets in the town of Stevenson on the west side of Seymour Street, thence west to west line of Shepard D.L.C.; thence north on west line to south line of Second Street; thence easterly along south line of Second Street to the west line of Seymour Street; thence Southerly along west line of Seymour St. to place of beginning
