RESOLUTION OF BOARD OF DIRECTORS OF THE CITIZENS NATIONAL BANK OF DALLES CITY.

Be it resolved by the Board of Directors of The Citizens National Bank of Dalles City, That P. J. Stadelman, President of said Bank be, and he is hereby authorized to make and deliver a Deed to The Citizens First National Bank of The Dalles, as a part of the assets of consolidation with The First National Bank of The Dalles, which Deed is made in pursuance of an agreement by the Board of Directors of both said Banks, under the Act of November 7th, 1918 to consolidate; which agreement was, on the 12th day of March, 1932, ratified by the shareholders of the two associations (Banks above named).

does hereby grant, bargain, sell and convey unto said The Citizens First National Bank of The Dalles, unto its successors and assigns, all the following real property, with the tenements, hereditaments and appurtenances, situated in the County of Skamania and State of Washington, to-wit:

Eight acres more or less, as described in deed from Dee Adamson to Bertha Spauling and recorded in Book U of Deeds of Skamania County, Washington, on Page #566, as recorded March 12th, 1926.

To Have and to Hold the above described and granted premises unto the said The Citizens First National Bank of The Dalles, a corporation, its successors and assigns forever.

The grantor covenants to and with the grantee, its successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, and that the above granted premises are free from all incumbrances, and the grantor shall warrant and forever
