Hilda Olin to State of Washington

IN THE MATTER OF Primary State Highway No 8-B., Blue Creek to Skadat.

KNOW ALL MEN BY THESE PRESENTS, That Hilda Olin, of the County of Hood River, in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of Five Hundred Dollars, in hand paid, the receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the State of Washington, the following described parcel of land situated in Skamania County, in the State of Washington, to-wit:

A strip of land 100 feet wide (except as may be hereinafter specified), being 50 feet wide on the northwestward side and 50 feet wide on the southeastward side of the center line of said highway as surveyed over and across Government Lot No. 9, Section 1, Township 2 North, Range 7 E. W. M. being portion thereof described as follows: beginning at a point 622 feet south and 60 feet west from the northeast corner of said Government Lot No. 9, thence south 256.2 feet thence west 100 feet; thence north 279.0 feet to the south line of of Primary State Highway No. 8, as now existing; thence east along the south line of Primary State Highway No. 8, as now existing, 100 feet; thence south 22.8 feet to the place of beginning.

the specific details concerning all of which are to be found within that certain map of definite location now of record and on file in the office of the Director of Highways at Olympia and bearing date of approval August 24th, 1937.

TO HAVE AND TO HOLD the same, unto the State of Washington forever.

It is understood and agreed that the delivery of this deed is hereby tendered and such tender kept good until revoked but that the terms and obligations hereof shall not become binding upon the State of Washington unless and until accepted and approved hereon in writing for the State of Washington, Department of Highways, by the Right of Way Engineer.
