## TIMBER SALE AGREEMENT

This agreement, made and entered into this 24th day of June, 1937, by and between M. Tavelli, party of thefirst part, and S. A. Obson, party of the second part, witnesseth:

That said party of the first part hereby agrees to sell to said party of the second part and said party of the second part hereby agrees to purchase of said party of the first part all standing timber on the following described tract of land, situated in the County of Skamenia, State of Washington, towit:

The southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$ ) The Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ NE $\frac{1}{4}$ ), and the West Half of the Southeast Quarter (W $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Section Thirty-five, Township Two North of Range "ive East of Willamette Meridian,

on the following terms and conditions: All timber cut by said second party on that part of said premises lying South of the road running over and across the Southwest Quarter off Southeast Quarter of said section to be paid for by said second part to said first party at the rate of One Dollar per thousand, board feet and log scale, and all timber cut by said second part on that part of said premises lying North of said road to be paid for by said second party to said first party at the rate of One and 25/100 Dollars per thousand, board feet and log scale; all timber so cut to be paid for immediately when manufactured in-to lumber, and all timber so cut and used for manufacture into ties to be paid for by said second party to said first party upon insection at the point of delivery by said second party and such payments to be made at intervals of not less than two weeks. All timber lying South of said road to be cut before cutting any timber lying North of said road.

Said second party agrees to place a tie mill upon said premises and commence tie
