THIS INDENTURE, Made this 15 day of December, 1937, in the town of Stevenson, County of Skamania, State of Washington, by and between M. W. Beck, the duly appointed, qualified and acting administrator of the estate of P. S. C. Wills, deceased, the party of the first part, and P. M. Aalvik, the party of the second part, WITNESSETH:
