# DEED RECORD Z

SKAMANIA COUNTY, WASHINGTON

### Tract No. 2-A

A strip of land situate in Government Lot 4 of said Section 25 that lies northwesterly of the northwesterly right of way line of the Spokane, Portland and Seattle Railway Company and southeasterly of a line parallel to and distant 80 feet northwesterly, measured at right angles and/or radially, from said hereinafter described center line of State Road No. 8 and extending northeasterly from a line drawn at right angles to said center line of State Road No. 8 from a point thereon designated as Highway Engineers Station 457 \$\frac{1}{2}\$50 thereof to the east line of said Government Lot 4.

### Tract No. 2-B

An additional strip of land 20 feet wide immediately adjoining on the northwesterly mide of the above described strip of land, and extending northeasterly from said line drawn at right angles to Highway Engineers Station 457/50 to a line drawn radially to said hereinafter described center line of State foad No.8, from a point thereon designated as . Highway Engineers Station 463/00 thereof.

### Tract No. 2-C

An additional strip of land 50 feet wide immediately adjoining on the northwesterly side of the last above described strip of land and extending northeasterly from a line drawn radially to said hereinafter described center line of State Road No. 8, from a point thereon designated as Highway Engineers Station 461/50 to said line drawn radially to said center line of State Road No. 8 from said Highway Engineers Station 463/00.

Said center line of State Road No. 8, hereinbefore referred to, as surveyed and constructed over and across said Government Lots 3 and 4 of Section 25, being more particularly described as follows, to-wit: Beginning at Highway Engineers Station 438/39.5 which is a point on the south line of said Government Lot 3 distance S. 89° 34° E. 11517 feet from the southwest corner of said Government Lot 3, measured along said south line; thence northeasterly on a curve to the left, having a radius of 2,218.h feet, a distance of 739.4 feet to a point, a tangent to said curve at point of beginning bears No. 61° 63° 30° E.; thence N. 42° 38° E. a distance of 1483.9 feet to a point; thence northeasterly on a curve to the right, having a radius of 2865.0 feet and which is tangent at its point of beginning to the last described course, a distance of 1700 feet to a point east of the east line of said Government Lot 4.

## Tract No. 3

A strip of land, being all those portions of Government Lots 2 and 3, Section 30, Town-ship 3 North, Range 10 East of the willamette Meridian, Skamania County, Washington, that lies southwardly of the following described line:

Beginning at a point on the west line of said Lot 2, northwardly from and 110 feet distant (measured at right angles) from the center line of State Road No. 8, Cooks-East to Underwood-West; thence on a line parallel with and distant 110 feet northwestwardly (measured at right angles from the center line of said road to Engineering Survey Station 489/00; thence southwardly on a line at right angles to said center line, 50 feet; thence on a line parallel with and distant 60 feet northwestwardly (measured at right angles) from said center line from Engineering Survey Station 489/00 to 496/50; thence northwestwardly on a line at right angles to said center line 40 feet; thence on a line, parallel with and distant 100 feet northwardly (measured at right angles) from said center line from Engineering Survey Station 496/50 to Engineering Survey Station 509/50; thence southwestwardly on a line at right angles to said center line 50 feet; thence southeastwardly on a line parallel with and distant 50 feet northeastwardly (measured at right angles) from said center
