The mortgagor(s) hereby mortgage(s) to the mortgagee, its successors and assigns, the following described real property, situated in the County of Skamania, State of Washington, to-wit:

Commencing at the intersection of the center of Rock Creek with the center line of State Road No. 8 as the same was located on August 30, 1924, said road now being in use as a county road in Section 1, Township 2 North, Range 7 E.W.M.; thence south 63° 24' west along the center line of said road 300 feet; thence north 26° 36' west a distance of 200 feet; thence north 63° 24' east to the center of Rock Creek thence in a southeasterly direction along the center of Rock Creek to the place of beginning; EXCEPTING easements for roads, power lines, telephone lines, and water pipe line in the Town of Stevenson, and SUBJECT to flowage easement granted to the United States of America.

TOGETHER with all right and interest therein, now owned or hereafter acquired, and all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, including, but not limited to, all heating, plumbing, lighting and ventilating apparatus, appliances or fixtures in or about any building now located on said premises or hereafter placed thereon, together with any and all renewals, betterments, additions or substitutions thereto, all of which said apparatus, appliances or fixtures are deemed by and between the parties hereto to constitute a part of the realty.

This mortgage is given and intended as security for the payment of the principal sum of TEN THOUSAND THIRTY-THREE and 50/100---Dollars (\$10,033.50) together with interest thereon in accordance with the terms of a certain promissory note of even date herewith, executed and delivered by the mortgagor in favor of the mortgagee, or its order, and any renewals or extensions thereof.

This mortgage is also given and intended as security for the payment by the mortgagor (s) to the mortgagee of such additional sums of money as may hereafter be loaned or advanced by the mortgagee to or for the account of mortgagor(s), including my renewals or extensions thereof, it being provided, however, that the unpaid principal balances of all loans or advances made by the mortgagee to or for the account of mortgagor(s) which are to be secured hereby shall not at any one time exceed the aggregate sum of \$10,033.50 and interest, regardless of any excess which may at any time be owing from said mortgagor(s) to the mortgagee; it being further provided that nothing herein contained shall be construed as obligating or shall obligate the mortgagee to make any such future loans or advances.
