DEED

THIS INDENTURE, Made and entered into this 5rd day of January, 1938, by and between Skamania County, one of the counties of the State of Washington, by and through its duly elected, qualified and acting Board of County Commissioners, hereinafter to be called and referred to as the "county"; and the State of Washington, hereinafter to be called and referred to as the "State", WITNESSETH:

WEREAS the county is now the owner and holder of certain real property as hereinafter described, acquired pursuant to tax foreclosure by the county;

AND WHEREAS, the state is desirous of purchasing the same for state park purposes;
AND WHEREAS, the Board of County Commissioners of said county have this day made and entered their resolution approving and authorizing the deliverance of a deed of said land to the state, subject to the conditions as hereinafter set out;

NOW THEREFORE the county, for and in consideration of the sum of One Dollar (\$1.00), in hand paid, grants, bargains, sells and conveys to the state the following described real property, to-wit:
