Lots numbered three (3), Four (4), Five (5), Six (6), Seven (7), Eight (8) Nine (9) and Ten (10) in Block B of the Original Town of Carson, Washington.

TO HAVE AND TO HOLD, the said premises with all their appurtenances, unto the said party of the second part and to his heirs and assigns forever; and the said John C. Meyer and Nora C. Meyer, parties of the first part, for themselves and for their heirs, executors and administrators, do covenant to and with the said party of the second part, his heirs and assigns, that they are the owners in fee simple of said premises and that they are free from all encumbrances except State and County taxes for the years 1934, 1935, 1936 and 1937 and a lease to said premises to Wm. G. Meneice, expiring on the 31st day of December, 1938.
