PRIVATE RIGHT OF WAY AND TREE TRIMMING PERMIT

Know all men by these presents, That Department of Fisheries State of Washington of Seattle State of Washington, for and in consideration of One and no/100 Dollars (\$1.00), receipt whereof is hereby acknowledged, hereby agrees to allow the West Coast Power Company, a Deleware corporation with principal offices at Portland, Oregon, to construct and permanently maintain an Electric Power Line over, along and across the following described property, to-wit:
