RIGHT-OF-WAY DEED (Road or Trail)

THIS INDENTURE, made the 3rd day of July in the year one thousand nine hundred and thirty six, between Joseph and Lorene Szydlo, husband and wife of the County of Skamania, State of Washington, grantors, parties of the first part, and the Secretary of Agriculture of the United States Department of Agriculture for and in behalf of the United States of America, grantee, party of the second part. WITNESSETH:

That for and in consideration of one dollar (\$1) in hand paid, receipt whereof is hereby duly acknowledged, the parties of the first part do hereby grant, bargain, sell, convey, and confirm unto the United States of America, an easement and right-of-way in gross over the following tract, lot, piece, or parcel, of land, situate, lying and being in the County of Skamania, State of Washington, and bounded and particularly described as follows:

The said right of way hereby granted is for the maintenance, and full, free, and quiet use and enjoyment by the United States of America for any and all purposes by them desired or deemed necessary or beneficial for or in connection with the control, administration, or use of the National Forests or the resources thereof, and, so far as may be with that enjoyment compatible, by the general public as a public highway being 40 feet in width, and traversing the above described premises according to the following general course and direction, to wit: Over and across the above described property.

This grant shall be effective only so long as said easment shall be actually used for any of the purposes above specified, but all rights hereunder shall revert to the owner of the fee as soon as the said use thereof shall be abandoned and discontinued.

The grantee shall at all reasonable times have right to enter for the purpose of constructing, repairing, and patrolling said right of way, doing as little damage as possible.
