IN THE MATTER OF SECONDARY STATE HIGHWAY No. 8-B., Washougal River to McPherson's Store.

KNOW ALL MEN BY THESE PRESENTS, That Monica A. Brodala, a widow, dealing with her separate property of the County of Skamania in the State of Washington, in consideration of the benefits and other valuable considerations, and the sum of One hundred and 00/100 Dollars, in hand paid, the receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the State of Washington, the following described parcel of land situated in Skamania County, in the State of Washington, to-wit:

A strip of land being all that portion of the NE $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 4, Township 1 North, Range 5 E.W.M. that lies southwardly from a line parallel with and distant 30 feet northwardly (measured at right angles) from the center line of said highway, except that from Engineering Survey Station 711/00 to Engineering Survey Station 709/00 said strip of land lies southwardly from a line parallel with and distant 50 feet northwardly (measured at right angles) from the center line of said highway and except that from Engineering Survey Station 708/00 to Engineering Survey Station 709/00, said strip of land lies southwardly from a line parallel with and distant 90 feet northwardly (measured at right angles) from the center line of said highway, reserving the right to maintain a fence south of creek where channel change may be constructed.

the specific details concerning all of which are to be found within that certain map of definite location now of record and on file in the office of the Director of Highways at Olympia and bearing date of approval August 24th, 1937.

TO HAVE AND TO HOLD the same, unto the State of Washington forever.

It is understood and agreed that the delivery of this deed is hereby tendered and such tender kept good until revoked but that the terms and obligations hereof shall not become binding upon the State of Washington unless and until accepted and approved hereon in writing for the State of Washington, Department of Highways, by the Right of Way Engineer.
