I, Henry Kapp, being first duly sworn, depose and say: That I am one of the grantors who, on September 14, 1937, made, executed and delivered to the United States of America, a flowage easement over a portion of land situate in Lot 1, Section 29, Township 3 North, Range 10 East of the Willamette Meridian, Skamania County, Washington, and more particularly described in said flowage easement. That said land is not subject to any vested or accrued water rights for any purposes in favor of United States of America or any third persons; nor is said land subject to the vested right of any proprietor of a vein or lode to extract and remove ore therefrom; nor is said land subject to any vested rights of way for ditches or canals constructed by authority of the United States.
