Notice is hereby given that The Federal Land Bank of Spokane, a corporation, plaintiff in the above entitled action, has instituted an action against Robert George O'Connor, Jr. and Ethel Marie O'Connor, husband and wife; Ella Moran, a widow; A. T. Sunderlin and Eva M. Sunderlin, husband and wife; and Skamania County National Farm Loan Association, a corporation, defendants.

That the object of said action is to foreclose a mortgage executed by Robert George O'Connor, Jr. and Ethel Marie O'Connor, husband and wife, to The Federal Land Bank of Spokane, for the sum of \$1000.00, dated March 9th, 1926, which mortgage is recorded in the office of the County Auditor of Skamania County, Washington, in Book Q of Mortgages, page 104, and covers the hereinafter described real property.
