And the said Grantors covenant that they are in the quiet and peaceful possession of said lands, and that they will and their heirs, executors and administrators shall warrant and forever defend the title to the right, power, privilege and easement hereby granted and conveyed, as aforesaid, to the Government or its assigns, against the lawful claims of all persons whomsoever.

And the said Grantors, in consideration of the above specified sum, also hereby release the Government from all claims for damages that have accrued or may hereafter accrue to them by reason of the overflowing of the above described land.

FLOWAGE EASEMENT (Office Chief of Engineers, Aug 5, 1936, 6500 (Bonneville Dam) 440/1)

THIS INDENTURE, made this 24th day of July, 1936, between C. T. Smith, also known as Charlie T. Smith in that certain warranty deed dated September 6, 1921, recorded November 1, 1921 in Book "S" of Deeds, page 407, Records of Skamania County, Washington; and also as Charley T. Smith in that certain quitclaim deed dated May 10, 1921, recorded June 7, 1922 in Book "S" of Deeds, page 602, Records of Skamania County, Washington; and also known as Charlie T. Smith in that certain Guardian's deed dated May 27, 1922, recorded June 7, 1922 in Book "S" of Deeds, page 600, Records of Skamania County, Washington, and Annabelle Smith, husband and wife since prior to May 10, 1921 (Annabelle Smith is designated as Constance Smith, wife of C. T. Smith, in that certain warranty deed dated March 13, 1924, recorded March 29, 1935 in Book "Y" of Deeds, page 136-7, Records of Skamania County, Washington), hereinafter called the Grantors, and the United States of America, hereinafter called the Government, witnesseth:

THAT WHEREAS, the Government is constructing a dam across the Columbia River between the States of Oregon and Washington at Bonneville, Oregon, and upon the completion of said
