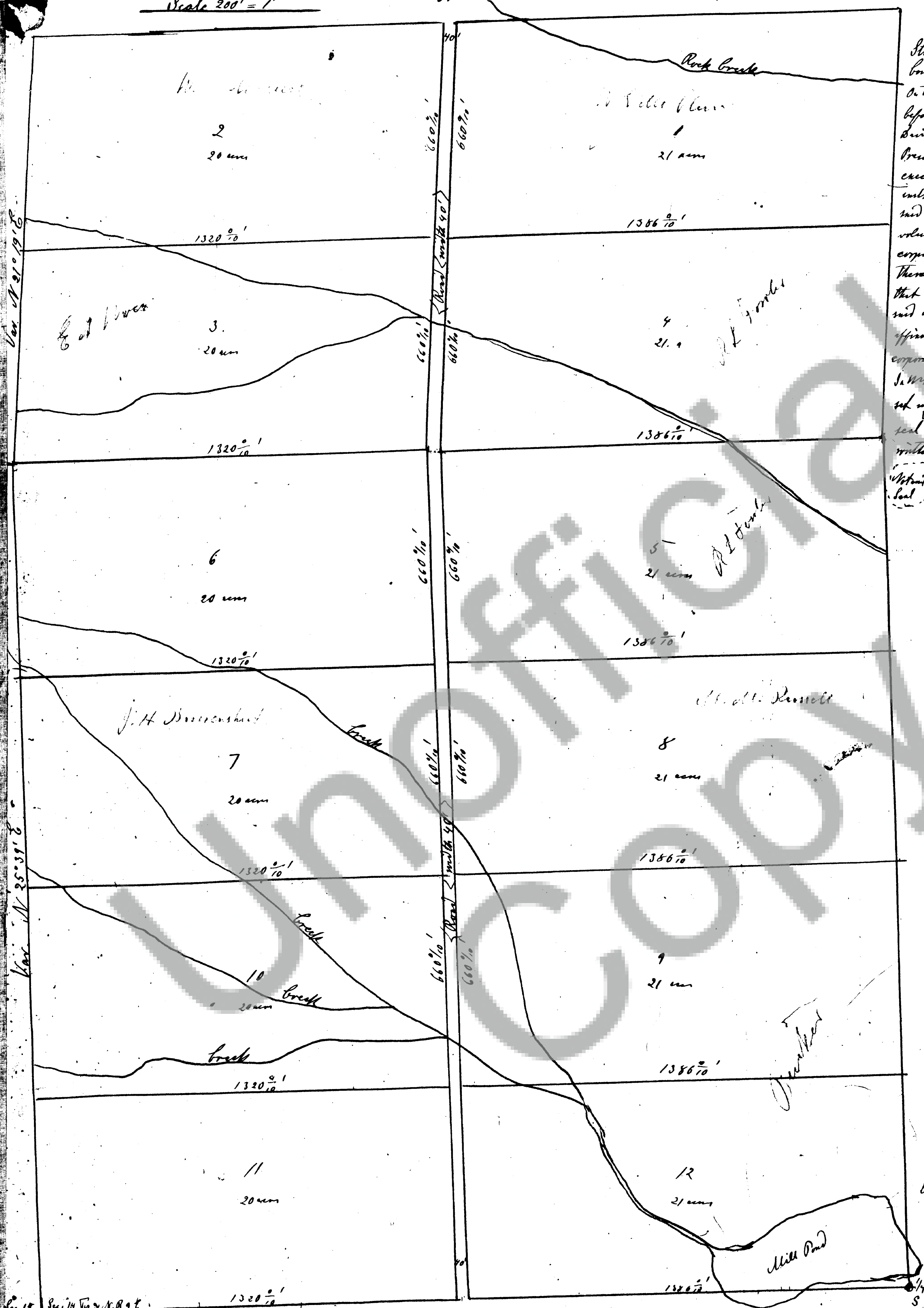

Property owners of East half of Lot 2 and The West half of Lot 1
of the offical plat by Oregon Lumber Company as recorded in The Book
A, page 29 of The Skamania County Auditor's recording of Plats.

Whereas on the 22nd day of December 1975 by resolution 53 A, The
Skamania County Board of County Commissioners did offically vacate the
northerly 660 feet of the dedicated road right-of-way shown on The Oregon
Lumber Company plat as recorded Book A, page 29 of The Offical Auditor's
records of Plats in Skamania County, with the exception of approximately
the northerly 150 feet there of which is currently occupied by The
Skamania County road known as Cook Underwood road.

Whereas it was the intent by said vacation to divest The County of
any public interest in said right-of-way.

Therefore be it understood that Skamania County herewith further
declares that all public interest in said right-of-way, that may of
existed, is herewith declared to be released offically by said road
vacation action of December 22, 1975 resolution 53 A.

Further The Board herewith directs the County Engineer to file
this document with The Skamania County Auditor's office to become an
offical document referring to right-of-way vacation within The Oregon
Lumber Company Plat recorded Book A, page 29 of The Skamania County
Book of Plats.
