The United states of America ,to all to whom these presents shall come,Greeting.

Whereas a certificate of the register of the Land office at Va couver, Washington has been deposite in the General Land office,whereby it appears that full payment has been made by the claimant Der Dorris M.Keen,according to the previsiens of the Act of Congress of April 24th 1820 enetitled "An act making further provisions for the sale of the public Lands " and the acts supplemental thereto,for the southwest quarter of the Northeast quarter,the east half of the Northwest quarter and th southwest quarter of the Northwest quarter of Section twenty-eight in Township two North of Range six East of willamette Meridian,Washington,containing one hundred and sixty acres, according to Government survey of said land returned to the General Land Office by the Surveyor General

Now Therefer,Knew Ye,that the United states of America in considearien of the p remises and in conformity with the several acts of Congress in such cases made and provided, Has given and granted and by these presents does give and grant unto the said Claimant and to the heirs of said claimant,the tract above described:To have and to hold the same together with all he rights privileges immunities and ap urtenances of whatsoever nature thereunto belonging unto the said claimant and to the heirs of said claimant forever;subject to any vested and accrued watersrights for mining,agriculture,manufacturing or other purposes and rights of ditches and reservoirs used in conection with such water rights as may be recognized and acknowledged by the local caustoms,laws and decisions of Courts;and there is reserved from the lands hereby granted a right of way thereon for ditches or canals consyructed by the authority of the United States.

In Testimo y Whereof I,William H.Taft,President of the United states have caused these letters to be made patent and the seal of the General Land office to be hereunto affixed.
