

be diverted by means of said dam and from thence conveyed by means of pipes ditches and flumes or combinations thereof downstream on the east side of the stream to a point hereafter to be selected which point shall not be beyond the section line between sections fourteen (14) and twenty three (23) township three (3) North of Range ten (10) east of Willamette Meridian and at the point hereafter selected will be used for the generation of electricity as hereinbefore set out, and thence returned to the river.

Know all men by these presents that we, Edgar Burlingame and Bell Burlingame husband and wife of Cooks Washington, in consideration of one dollar and other valuable considerations to us paid by Gerald A. Rolfes of Chicago Illinois have bargained and sold and by these presents do bargain, sell and convey unto said Gerald A. Rolfes his heirs and assigns the following bounded and described real property situated in the County of Skamania State of Washington to-wit:

Beginning at the Northeast corner of the Southeast quarter of the Southeast quarter of section ten (10) in Township three (3) North of Range nine (9) East of Willamette Meridian, running thence west along the forty acre tract line, forty (40) rods; thence south parallel with the east line of said section ten, sixty (60) rods, thence east parallel with south line of said section, forty (40) rods; thence north along the section line sixty (60) rods to place of beginning, containing fifteen (15) acres, excepting therefrom a strip of ground twenty (20) feet wide running east and west along the north line and side of the above described land for a road right of way, together with the tenements hereditaments and appurtenances thereunto belonging or in anywise appertaining and also all our right title and interest in and to the same including dower and claim of dower.
