In consideration of One Dollar, the receipt whereof is hereby acknowledged, H.V.Rominger, and Alice Romingor, hudband and wife, grant to Northwestern Electric Company a perpetual right-of-way in and over the following described real property, situated in County of Skamania county, State of Washington, to-wit: The South one-half of the S.W. of the N.E. of Section twenty-one (21) Township three (3) North, Range Ten (10) East of the willamette Meridian. for the purpose of erecting, maintaining and operating thereon one pole or tower line for the transmission of electric current; together with the right to cut such trees and brush as may be necessary in constructing, maintaining and protecting such lines from damage. The line is surveyed and enters the land five feet west of the S.E. Corner; thence North along the gast Line and five (5) feet therefrom to the North line.

The towers or poles shall be about 330 feet apart and the one in the center shall stand upon the ledge of rock along the East Line of the land. It is understood that the cross arms on the poles or towers will be seven or eight feet long and the poles or towers shall stand so that no encroachment of the arms or wires will be upon the adjoining land.
