Haselton to Northwestern Electric Company.

In consideration of One Dollar, the receipt whereof is hereby acknowledged, Leta Ruth Haselton, (formerly Leta Ruth Weßels) grants to Northwestern Electric Company a perpetual right-of-way in and over the following described real property, situated in County of Skamania State of Washington, to-wit: The North Half of the Southwest Quarter of the Northeast Quarter of Section twenty-one in Township 3, North of Range 10 East of the Willamette Meridian. Said grantor acquired said land prior to her marriage with R.H.Haselton, and the same is not community property. for the purpose of erecting, maintaining and operating thereon one pole line for the transmission of electric current; together with the right to cut such trees and brush as may be necessary in constructing, maintaining and protecting such lines from damage.

The line shall be constructed along the east line of said tract not to exceed eight feet from said east line and one pole shall be at the south line of the tract, one near the center of the East line of the tract and another at the County Road, near the North line of the tract. The Company shall pay all damages to crops or fences which may be done while repairing or inspecting transmission line, or any other damages to the land after first construction.
