

LETA RUTH HASELTON TO NORTHWESTERN ELECTRIC COMPANY

KNOW ALL MEN BY THESE PRESENTS, THAT LETA RUTH HASELTON, FOR AND IN CONSIDERATION OF THE SUM OF TWENTY-FIVE (25) DOLLARS, TO HER PAID BY NORTHWESTERN ELECTRIC COMPANY, HEREBY GRANTS TO SAID COMPANY THE RIGHT TO MAINTAIN THIS POLE LINE WHERE THE POLES NOW STAND ON THE NORTH HALF OF THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION 21, IN TOWNSHIP 3 NORTH OF RANGE 10 EAST, OF THE WILLAMETTE MERIDIAN, IN SKAMANIA COUNTY, WASHINGTON.

THIS AGREEMENT IS TO CORRECT A MISTAKE OF SETTING THE POLES UNDER A RIGHT-OF-WAY GRANTED BY LETA RUTH HASELTON TO SAID COMPANY UNDER DATE OF THE 28TH OF AUGUST, 1912, ONE OF SAID POLES BEING SET NORTH OF THE SOUTH LINE OF SAID TRACT, INSTEAD OF AT THE SOUTH LINE OF SAID TRACT.
