KNOW ALL MEN BY THESE PRESENTS, That W. A. Arnold and Fannie A. Arnold, his wife, parties of the first part, for and in consideration of the sum of One Dollar do hereby grant and convey unto the Town of Stevenson, a municipal corporation, the right to take water from Leborg Creek at a point near the East line of the NW $\frac{1}{4}$  of SE $\frac{1}{4}$  Section 34, Twp. 3 North, Range 3 E. W. M., Skamania County, Washington, at a point now exceeding 75 feet up stream from the place where the intake is now located, together with the right to construct dam, impounding or intake reservoir and an easement for a right-of-way therefrom, over and across the above described land for a pipe line.

It is understood that the grantors are the owners of an undivided one-half interest in the above described premises and that this conveyance is for and covers only such interest as the parties of the first part have therein or shall hereafter acquire thereto.
