Easement Deed

The Grantors Elder W. Dietderich and E. Estelle Dietderich, husband and wife of Skamania County, Washington for and in consideration of One Dollar (\$1.00) Dollars² in hand paid, CONVEY and WARRANT to Pacific Power & Light Company, a corporation, its successors and assigns, an easement or right-of-way for an electric transmission and distributing line of one or more wires and all necessary or desirable appurtenances (including telephone and telegraph wires, towers, poles, props, guys and other supports and including the right to place all said lines ⁱⁿ underground conduits) at or near the location and along the general course now located and staked out by the grantee over, across and upon the following described premises, located in _____ County, _____ to-wit::

The southwest quarter (SW $\frac{1}{4}$) of the southeast quarter (SE $\frac{1}{4}$) of Section 24, township 3 North, range 9 east, Willamette Meridian, and the northwest quarter (NW $\frac{1}{4}$) of the Northeast quarter (NE $\frac{1}{4}$) of Section 25, township 3 north, range 9 east, Willamette Meridian and the northeast quarter (NE $\frac{1}{4}$) of the northwest quarter (NW $\frac{1}{4}$) of section 25, township 3 north, range 9 east, Willamette Meridian.

Together with the right of ingress and egress over the adjacent lands of the Grantors for the purpose of constructing, reconstrudting, stringing new wires on, maintaining and removing said lines and appurtenances and exercising other rights hereby granted.

All rights hereunder shall cease when said lines have been abandoned.
