IN THE MATTER OF PRIMARY STATE HIGHWAY No. 8, Blue Creek to Skadat

KNOW ALL MEN BY THESE PRESENTS, That Etta Hoag, dealing with her separate property, of the County of Gilliam in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of Sixty and 00/100 Dollars, in hand paid, the receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the State of Washington, the following described parcel of land situated in Skamania County, in the State of Washington, to-wit:

A strip of land 100 feet wide, being 50 feet wide on the northwestward side and 50 feet wide on the southeastward side of the center line of said highway as surveyed over and across the following described tract of land, situate, lying and being in the county of Skamania, to-wit: the northeast corner of which is situate and lying 748 feet south and 310 feet west of the northeast corner of Lot 9, Section 1, Township 2 North, Range 7 E.W.M., thence south 110 feet thence west 50 feet; thence north 110 feet; thence east 50 feet to the place of beginning, being all that portion of said tract lying between said boundary lines.

Tract from which right of way is taken is a portion of Gov. Lot No. 9, Section 1, Township 2 North, Range 7 E.W.M.

the specific details concerning all of which are to be found within that certain map of definite location now of record and on file in the office of the Director of Highways at Olympia and bearing date of approval August 24th, 1937.

TO HAVE AND TO HOLD the same, unto the State of Washington forever.

It is understood and agreed that the delivery of this deed is hereby tendered and such tender kept good until revoked but that the terms and obligations hereof shall not become binding upon the State of Washington unless and until accepted and approved hereon in writing for the State of Washington, Department of Highways, by the Right of Way Engineer.
