This Indenture made this 12th day of May, A.D. 1928 between A. C. Sly, as Treasurer of Skamania County, State of Washington, party of the first part, and Harold Anderson, party of the second part:

WITNESSETH, That, whereas, at a public sale of real estate held on the 12th day of May, A.D. 1928, pursuant to a real estate tax judgment entered in the Superior Court in the County of Skamania on the 3rd day of April, A.D. 1928, in proceedings to foreclose tax liens upon real estate and an order of sale duly issued by said Court, Harold Anderson duly purchased in compliance with the laws of the State of Washington, the following described real estate, to-wit:
