Beginning at a point on the Southerly line of the Evergreen Highway, which said point is south 81° 00' East 633 feet from a point which is South 1257 feet and West 38.93 feet from the common corner of Sections 15, 16, 21 and 22, Township 2 North of Range 7 East of the Willamette Meridian, and running thence South 81° 00' East, along the Southerly line of said highway, 30 feet; thence South 9° 00' West 50 feet; thence North 81° 00' West 30 feet and thence North 9° 00' East 50 feet to the place of beginning, said tract being designated as the Easterly 17 feet of the North half of Lot 13 and the Westerly 13 feet of the Northhalf of Lot 12 in Block 1 of the unrecorded plat of the Town of North Bonneville, Skamania County, Washington.
