That portion of section 14, township 2 north, range 7 east W. M., lying west and south of D. F. Bradford D. L. C. #37 between State Highway #8 on the South, Wauna Lake Road on the West, and the old county road on the North, more properly described as follows:

BEGINNING at the intersection of D. L.
