Sheldon E. Baxter et ux to Joe A. Gaines

To Whom These Presents Shall Come,

Be it hereby known and agreed that we, Sheldon Baxter and Lillian Baxter, husband and wife, residing at Skamania Washington, being of sound mind and of our own free will and accord, do hereby grant to Joe A. Gaines of Skamania, Washington, fifty percent of all oil or oil Royalties obtained from the hereinafter described property for and in consideration of a loan of Three Hundred Twenty Two Dollars. for one year at 6 percent interest.

Commencing at a concrete monument set in the ground at a point 800 feet West and 177 feet South of the quarter corner on the East line of Section Twenty Six, Township Two North, Range Six, East of the Willamette Meridian, thence running South 48.45 feet, thence West 5.68 feet to the initial point. Thence from said initial point North 37 degrees & 29 feet West 12 feet, thence South 62 Degrees & 9 feet. West 291.85 feet, thence south 68 degrees & 41 feet, West 147.9 feet thence south 56 degrees 29 feet, west 96.86 feet thence south 1 degree 47 feet West 51.15 feet, thence South 5 degrees 10 feet, East 816.39 feet, thence north 69 degrees 30 feet East 548.00 feet, thence north 3 degrees 50 feet, West 238.04 feet, thence north 1 degree & 50 feet, East 190.61 feet thence north 23 degrees 22 feet, East 47.65 feet, thence north 68 degrees & 26 feet, west 238.94 ft. thence north 16 degrees & 42 ft. East 364 ft. to the initial point. (the last three courses above given coincide with the Westerly line of tract heretofore conveyed to Leonard Forsythe and Nora Forsythe, his Wife, by deed, recorded in book Z of deeds, page 343, records of Skamania, County Washington.
