Haul Road Permit

IN THE MATTER OF PRIMARY STATE HIGHWAY NO. 8, CAPE HORN TO SKAMANIA.

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of Two Hundred Fifty (\$250.00) Dollars, in hand paid, the receipt whereof is hereby acknowledged, do hereby grant and warrant unto the STATE OF WASHINGTON, the right, permit, license and easement to use and occupy the hereinafter described lands for the purpose of a haul road, said lands being situated in Skamania County, State of Washington and described as follows, to-wit:

A strip of land 30 feet wide and approximately 3600 feet long, to be used as a haul road, extending from the Westerly line of Stock Pile Site No. 4462, Westerly to Quarry Site No. S.A 29, as surveyed over the Southwest Quarter of the Southeast Quarter and the Southeast Quarter of the Southwest Quarter and the Southwest Quarter of the Southwest Quarter of Section 1, and the Southeast Quarter of the Southeast Quarter of Section 2, all in Township 1 North, Range 5 East, W.M., the
