Anna DelGrosso to Skamania County

THIS INDENTURE made and entered into by and between Anna DelGrosso, surviving spouse of Ben DelGrosso, deceased, and successor in interest to the community property of the said decedent and grantor under contract relating to community property recorded at page 365 Volume "32" of Deeds, records of Skamania County, Washington, party of the first part, and Skamania County, a legal subdivision of the State of Washington, party of the second part, WITNESSETH:

WHEREAS, by deed dated December 5, 1947, and recorded December 8, 1947, at page 553, Volume "31", record of Deeds of Skamania County, Washington, the said party of the first part and Ben DelGrosso, then her husband, conveyed to Skamania County a certain triangular tract of land more fully described in the above mentioned deed, reference to which is hereby made, and

WHEREAS, it was intended by said instrument to convey to said Skamania County a right and easement to take water from a certain well hereinafter described but by inadvertence and mutual mistake the said easement was omitted from said deed.

NOW THEREFORE, in order to correct the said instrument and in consideration of the sum of One Dollar, the receipt of which is hereby acknowledged, the party of the first part does hereby CONVEY and GRANT unto the party of the second part the right and easement to take from that certain well situate in the southwesterly part of the Northeast Quarter (NE $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section Three (3), Township One (1) North, Range Five (5) E. W. M. belonging to the party of the first part an amount of water not to exceed in quantity that which will flow through a one inch pipe, together with an easement over and across the property of the party of the first part in a southeasterly direction to the real property conveyed to Skamania County as aforesaid for the purpose of laying therein and thereover a pipe line for the conveyance of said water and the right to go upon said premises to repair, maintain or replace said pipe line, the said pipe line to
