Bates, 5615 N. 24th Avenue, Portland, Oregon hereinafter referred to as Grantors, (whether one or more), do hereby grant and convey unto PACIFIC NORTHWEST PIPELINE CORPORATION, a Delaware corporation, its successors and assigns, hereinafter referred to as Grantee, the right to select the route for and construct, maintain, inspect, operate, protect, repair, replace, alter or remove a pipeline or pipelines for the transportation of oil, gas and the products thereof, on, over and through the following described lands, which Grantors warrant that they are the owners in fee simple, situated in the County of ; State of Washington Skamania The East Half of the Southwest Quarter (E2 SW4) of Section 27, Township 2 North, Range 6 E.W.M.; EXCEPT the following described tract: Beginning at the Northeast corner of the Southeast Quarter of the Southwest Quarter (SE4 SH4) of the said Section 27; thence South to a point where the county road intersects the East line of the Southeast Quarter of the Southwest Quarter (SE SW4) of the said Section 27; thence following the Easterly line of the said County Road Northerly to intersection with the North line of the SE4 of the Southwest Quarter (SW4) of the said Section 27; thence East to the point of beginning; and EXCEPT rights of way for roads. together with the right of in-Township_ , Range gress and egress to and from said line or lines, or any of them, for the purposes aforesaid; hereby releasing and waiving, as to Grantee, all rights under and by virtue of the homestead exemption laws of said state. Grantee agrees that after it has completed its survey of the route for its pipeline and has established the route thereof and before pipeline construction is commenced, it will pay Grantors; in proportion to Grantors respective interests, a total sum equivalent to One (\$1.00) Dollar per lineal rod of pipeline so surveyed and established. Grantors shall have the right to use and enjoy the above described premises, except as to the rights herein granted; and Grantors agree not to build, create or construct or to permit to be built, created or constructed any obstruction; building, engineering works, or other structures over or that would interfere with said pipeline or lines or Grantee's rights hereunder. Grantee hereby agrees to pay any damages which may arise to growing crops, pasturage, timber, lences or buildings of said Grantors from the exercise of the rights herein granted; said damages, if not mutually agreed upon, shall be ascertained and determined by three disinterested persons, one to be appointed by the undersigned Grantors, their successors, heirs or assigns, one to be appointed by the Grantee, its successors or assigns, and the third by the two so appointed, and the written award of such three persons shall be final and conclusive. Should more than one pipeline be laid under this grant, at any time, an additional consideration, calculated on the same basis per lineal rod as specified above, shall be paid for each such line laid. It is agreed that the obligation of Grantee to make any payment hereunder shall be satisfied by delivery of such payment to any of the Grantors for the benefit of all Grantors. Any pipeline constructed by Grantee across lands under cultivation shall, at the time of construction thereof, be buried to such depth as will not interfere with such cultivation. The Grantee shall have the right to assign this grant in whole or in part.

TO HAVE AND TO HOLD said right-of-way and easement unto said Grantee, its successors and assigns until such first pipeline be constructed and so long thereafter as a pipeline is maintained thereon.
