

QUITCLAIM DEED

THE GRANTOR, GEORGE R. BAY, for and in consideration of the sum of One Dollar and the love and affection he has for his sister, GRANTEE NORMA J. WRIGHT, hereby conveys and quit claims unto said Grantee all of his rights, titles and interests of any nature whatsoever in and to the following described real property situated in the County of Skamania, State of Washington, to-wit:

Beginning at the intersection of the south line of Section 36, Township 3 North, Range 7, east of the Willamette Meridian, and the west line of the Henry Shepard D.L.C.; thence east 115.6 feet; thence north  $61^{\circ} 40'$  east 1557.1 feet to the intersection of the center line of Vancouver Avenue and the center line of Kanaka Creek Road, thence north  $36^{\circ} 27'$  west 118.2 feet along the center line of Kanaka Creek Road; thence north  $55^{\circ} 44'$  west 301.8 feet along the center of Kanaka Creek Road to the initial point of the tract to be described, which is also the initial point of that tract of land described in deed recorded at page 417, volume 31 of deeds, records of Skamania County, Washington, thence from said initial point north  $61^{\circ} 40'$  east to intersection with the center line of Lateral Highway No. 3; thence southerly along the center of Lateral Highway No. 3 to intersection with the center line of Kanaka Creek Road; thence following center line of Kanaka Creek Road northerly to the point of beginning; all situated in Section 36, Township 3 North, Range 7, east of the Willamette Meridian.

ALSO: For the point of beginning commence at the intersection of the center line of Vancouver Avenue (sometimes called Cascades Road) with the center line of Kanaka Creek Road in Section 36, Township 3 North, Range 7, east of the Willamette Meridian, thence northerly along the center line of said Kanaka Creek Road a distance of 430 feet to the initial point of tract herein conveyed; thence north  $61^{\circ} 40'$  east to center of Kanaka Creek; thence following the center of Kanaka Creek northerly to intersection with the south line of Stevenson Park Addition according to the official plat thereof on file and of record in the office of the Auditor of Skamania County, Washington, thence west to intersection with the center line of the old survey of Strawberry Road, thence westerly along the center line of the old survey of Strawberry Road to intersection with the center line of Kanaka Creek Road; thence along the center line of Kanaka Creek Road in a southerly direction to the point of beginning.

EXCEPTING THEREFROM all that portion thereof lying on the southeasterly side of the County Road running through said tract.
