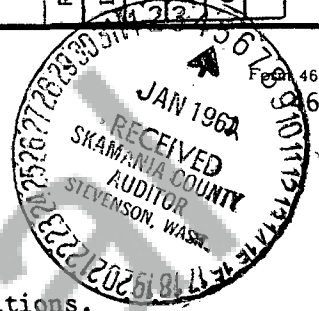

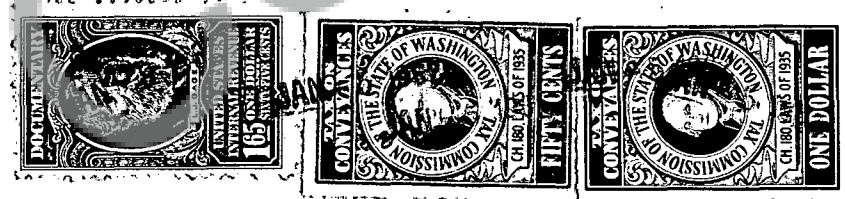
THE GRANTOR, HAZEL O. PRICE, a widow,
