SUBJECT TO easements and rights of way for the county road known and designated as Strawberry Road.

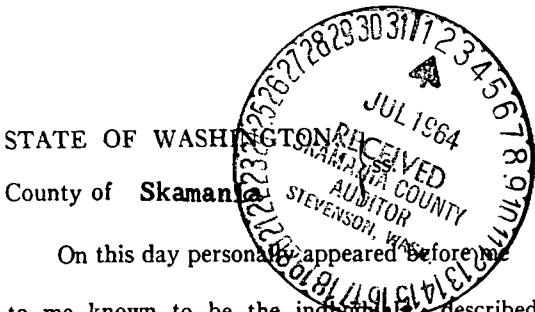
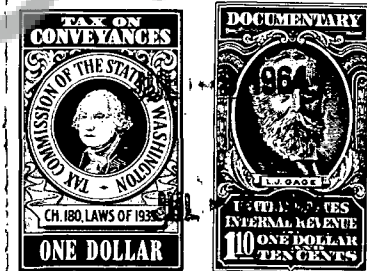
